

Customer Migration to Higher Tariff Bands in Lafia, Nasarawa State

Following the completion of the 330KVA Akurba Power Substation implemented by the Federal government in Nasarawa State, the quality of supply to customers in the state especially in Lafia has improved significantly. The hours of supply have increased from 8 hours and below to above 20 hours. In view of this service improvement and in compliance with regulatory standards under the Service Reflective Tariff (SRT), customers placed on lower tariff bands will be upgraded to higher tariff Bands reflective of the hours of supply.
