1. Evidence of registration with the Corporate Affairs Commission (CAC)
2. Company profile with details of key personnel and equipment
3. Tax Clearance Certificate for the last three (3) years
4. Evidence of compliance with the Pension Reform Act (PENCOM certificate)
5. Evidence of compliance with Industrial Training Fund (ITF) contribution requirements
6. Evidence of compliance with the Nigeria Social Insurance Trust Fund (NSITF)
7. Verifiable evidence of similar projects executed in the last five (5) years (attach letters of award, completion certificates, photographs, etc.)
8. Evidence of financial capability (reference letter from a reputable Nigerian bank)
9. Health, Safety & Environment (HSE) policy statement
